**Individual Stewardship Plans (ISP)** – Currently 2 plans were completed and 1 new VSP applicant was enrolled. H Crose presented a question on natural wetlands vs CB project induced wetlands. E. Pentico provided clarification on the question.

**Monitoring Plan** – B. Baker provided an update on monitoring plan implementation. H. Crose suggested evaluating the benefits of mid-summer monitoring for groundwater. B. Baker will provide feedback on this issue at the winter quarterly meeting.

**OGWRP Update** – H. Crose provided an update on OGWRP for the 11.8 and 22.1 systems located in Grant County. H. Crose also provided an update on the PL566 status.

**MDI** – H. Crose and W. Haughton provided an update on the mobile drip irrigation systems program. Currently 1.5 million is dedicated to putting in MDI systems (~25 projects). The projects will be monitored for 10 years to evaluate effectiveness and delineate total water savings. Three systems will be implemented in the spring and three systems are in the process of being contracted.
